## DIRECTIONS FOR USE

FOR USE IN FOOD PROCESSING PLANTS, WAREHOUSES, HOTELS AND MOTELS, OFFICE AND INDUSTRIAL BUILDINGS, HOSPITALS, THEATERS AND KENNELS

It is a violation of Federal law to use this product in a manner inconsistent with its label.

**ACTIVE INGREDIENTS:**

- d-trans Allethrin (allyl homolog of Cinerin I) .....0.250%
- Piperonyl butoxide, technical\* .....0.500%
- N-octyl bicycloheptene dicarboximide .....0.834%

**TO KILL FLIES, MOSQUITOES, GNATS AND SMALL FLYING MOTHS:** Close room, warehouse or other area to be treated and shut off all ventilating systems. Dispense product as a fine mist using a hand sprayer, mist sprayer or thermal fogger. Use 1/2 to 1 fluid ounce per 1000 cubic feet of room space. Do not remain in treated area. Leave room closed for one-half hour. Ventilate area after treatment is completed. Repeat application as needed for insect control.

**CAUTION**

**FIRST AID**

**ENVIRONMENTAL HAZARDS**

This product is highly toxic to fish, birds, and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on label. **PHYSICAL AND CHEMICAL HAZARDS**

**TO KILL COCKROACHES, ANTS AND CRICKETS:** Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. To kill ants, treat door sills, window frames, ant trails and other areas of entry.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage and disposal.

**STORAGE:** Keep container tightly closed when not in use. If container is damaged or leaking, contain spill. Soak up spilled material with sand or other inert absorbent and place in a closed, labeled container for proper disposal.
